SUPERINTENDENT'S REPORT

STUDENT & STAFF RECOGNITION

Dr. Alvarado highlighted and congratulated the Jazz Band, Varsity Choir and staff/directors for another successful **Showtime** production. This year marks 45 years of Showtime.

Students in the Engineering Architecture, Technical Design, and Intro Design Engineering Honors courses participated in the 2025 Helm VDC Competition. Students competed for both cash awards and a paid summer intern position. Awards were presented to:

Evan Scudder - 1st Place, cash prize, and a paid Summer Internship Asher Kittoe - 2nd Place, cash prize Mitchell Schneiderman - 3rd Place, cash prize

Stacey Kleindl, Principal of Blackhawk Elementary in Freeport School District 145, was selected for a Spotlight Recognition at the 9th Annual Illinois Association of Latino Administrators and Superintendents (IALAS) Conference. Each year, IALAS honors outstanding educators through its Spotlight Leader feature. Mrs. Kleindl received this recognition for her exceptional leadership, commitment to inclusion, and remarkable academic progress at Blackhawk—particularly among multilingual learners.

Congratulations were extended to **Board President**, **Jack Sosnowski** on receiving the **IL Association of School Boards Board Leader Recognition Award**.

OTHER SUPT REPORTS

Sara Latimer, Director of **Early Childhood**, provided the board with an update on the **Preschool Expansion project.** She discussed Community Partnerships Development, EC Transition Advisory Team Members, Mascot & Logo, Parent Survey, MTSS Development, FAQ for Parents and next steps.

Dr. Alvarado discussed IDPH: Action Needed to Improve Measles Protection Rates and Outbreak Readiness Evaluation IDPH requires students to be vaccinated to protect themselves, classmates, and staff. Vaccination directly shields individuals and helps contain disease spread, especially for those who are ineligible for certain vaccines. To maintain community immunity, schools should aim for 96% coverage, with a minimum of 91% to achieve herd immunity. Our district has an immunization protection rate for measles of 97.4%

The National Assessment of Educational Progress (NAEP), also known as The Nation's Report Card, is the largest nationally representative assessment of student achievement in the U.S., providing consistent data across states and time. It serves as a valuable benchmark for contextualizing local assessment results, helping to reveal trends, disparities, and the relative rigor of state and district-level tests. The attached presentation compares NAEP data trends with FSD145 data. By comparing local data to NAEP, educators and policymakers can better understand student performance within a national framework.

This program is sponsored by the Illinois Association for Behavioral Health (IABH) and promotes positive change, healthy decision-making, and leadership development among young people from across Illinois. It is proposed that, as part of the FSD145 Summer Programming offered in 2025, a team of approximately 14 students and 2 adult mentors to attend CGTI this July. Cost of this summer learning experience will be approximately \$7,750 and will be

funded through the After-School Programs Grant. Approval is requested at the May 6th meeting.

P.E. & Health Curriculum: Since May of 2024, the K-8 and 9-12 Physical Education Departments, comprising physical education, health, and driver education teachers, have worked to develop a curriculum, based on the Illinois State Standards for their content areas, that establishes goals for students and efficiently utilizes Board-approved materials. The team came to a consensus about resources and materials to recommend to the FSD145 School Board of Education for the next adoption cycle that will lead to a comprehensive, vertically-aligned curriculum that will better assist in meeting the goal of empowering students to make healthy lifestyle choices from kindergarten through graduation and beyond. Approval is requested at the May 6th meeting.

Social Studies Curriculum Review: Since January of 2024, the Social Studies Curriculum Review Committee and Social Studies Departments have worked to develop a curriculum that is based on the Illinois Social Science Standards, that establishes goals for students and efficiently utilizes Board approved materials. The Social Studies Curriculum Review committee has prepared a plan for integrated curriculum for grades K-4; curriculum maps for grades 6-12, and materials recommendations for the FHS Social Studies elective courses. Approval is requested at the May 6th meeting.

Elementary Report Card: During the second year of the HMH ELA materials (phase 6 of the curriculum review cycle), a representative group of teachers piloted a curriculum map of prioritized standards. This process led to the refinement of the standards being prioritized and assessed, resulting in further refinement in the reported standards. The updated K-4 report cards are aligned with the Illinois Priority Standards, The HMH Assessments, and the newly developed ELA Curriculum Maps.
