### **Monthly Financial Report**

I was provided by Dr. Patrick McDermott through the end of September. He advised we will move forward with the bond sale. He advised that a new treasurer and IMRF agent will be appointed later in the meeting.

### **Bilingual Education Department Report**

Dr. Rocio Del Castillo gave an update of this newly formed department. She shared their mission statement; IL definition of a multilingual learner; federal and state regulations; 17 languages spoken in FSD; goals and targets.

#### **Bullying Prevention Policy**

Current policy was approved in February of this year. ISBE mandates adding this additional paragraph:" Nothing in this Section is intended to infringe upon any right to exercise free expression or the free exercise of religion or religiously based views protected under the First Amendment to the United States Constitution or under Section 3 of Article 1 of the Illinois Constitution."
