Recognitions

Supt. Alvarado acknowledged **Black History Month**: The Black History Month 2024 theme, "African Americans and the Arts," explores the key influence African Americans have had in the fields of "visual and performing arts, literature, fashion, folklore, language, film, music, architecture, culinary and other forms of cultural expression."

Congratulations to FSD on becoming a **PlayCore National Demonstration Site**. We received this award for the design and implementation of our new elementary playgrounds. While every elementary school has new playground equipment, Blackhawk School was designated by PlayCore as the demonstration site. The recognition signage is located at Blackhawk. The award recognizes our commitment to advancing play and recreation and activating meaningful experiences for our students.

ISBE Exclusionary Discipline Metrics

Dr. Alvarado, Asst. Supt, Dan Holder and Asst. Supt. Dr. Shalonda Randle discussed our Discipline Metrics. Section 2-3.162 of the School Code requires ISBE to determine the top 20% of school districts in the following metrics. Our district has been identified as being in the top

20% for one or more of the exclusionary discipline metrics below. Specific details were provided by each metric.

- a. Total number of out- of -school suspensions
- b. Total number of out- of- school expulsions
- Racial disproportionality defined as overrepresentation of students of color or white students in comparison to the total number of students of color or white students on Oct.
 1 of the school year in which the data are collected. Calculations use the same method as the U.S. Dept. of Education's Office for Civil Rights

Exploring Alternative Programming Opportunities

Presented by Asst. Supt, Daniel Holder. In light of increasing tuition costs statewide for therapeutic programs along with decreased capacity/seats in many programs within our region, the PPS department is beginning to explore opportunities to expand the continuum of services available within the district. We are taking initial steps to conduct a more comprehensive needs assessment to better identify programmatic support of evolving needs with the goal of presenting options for board review and feedback in the coming months. *Please note this is in an exploratory, assessment phase.*

GoalBook

Presented by Asst. Director, Dr. Sue Waughon. Goalbook is an IEP compliance and reinforcement tool that provides instructional tools along with professional development and technical support aligned to research based frameworks and state standards. Through use of Goalbook, special education teams are better equipped to identify learning barriers and apply effective strategies so that all students progress within their unique goal areas. We currently have a partnership with Goalbook to support special education teachers with designing learning goals and instructional plans that effectively translate to positive student outcomes on IEP goals

PLC Data Survey

Presented by Dr. Alvarado and Asst. Supt. Dr. Julia Cloat. Strategy 3.2 of the FSD145 Strategic Plan calls for the District to "create, implement, and monitor a comprehensive professional learning plan that includes a responsive, data-based approach to professional learning design." A key action of this strategy is to monitor the implementation of professional learning communities through a series of surveys during the 2023-2024. The PLC Implementation Survey was given to the staff for the second time at the Winter Institute Day on January 24, 2024.
